## RESOLUTION OF THE ORANGE COUNTY COMMITTEE ON SCHOOL DISTRICT ORGANIZATION APPROVING THE ESTABLISHMENT OF TRUSTEE AREAS, CHANGE TO THE METHOD OF ELECTION TO A BY-TRUSTEE AREA ELECTION PROCESS AND ESTABLISHMENT OF SEQUENCE OF ELECTION IN THE HUNTINGTON BEACH UNION HIGH SCHOOL DISTRICT

WHEREAS, on September 21, 2023, the Huntington Beach Union High School District ("School District") submitted a proposal to the Orange County Committee on School District Organization ("County Committee") to establish trustee areas and change the method of election to a by-trustee area election process; and

WHEREAS, Education Code section 5019 provides that a proposal to establish trustee areas or to change its method of electing governing board members as specified in Education Code section 5030 may be initiated by resolution of the governing board of a school district; and

WHEREAS, Education Code section 5030 authorizes alternative methods of electing school district governing board members, including at-large, hybrid, and by-trustee area elections; and

**WHEREAS,** by Resolution No. 2-2023/24, the Board of Trustees of the Huntington Beach Union High School District adopted a by-trustee area electoral system for consideration by the County Committee; and

WHEREAS, on November 2, 2023, as required by Education Code section 5019, and after having complied with all notice requirements, the County Committee met within the boundaries of the Huntington Beach Union High School District, to conduct a public hearing to consider the proposal to establish trustee areas and change the method of election to a by-trustee area election process in the School District; and

WHEREAS, Huntington Beach Union High School District's proposal, supporting materials, and presentation demonstrate that the School District initiated its proposed change to by-trustee-area elections in furtherance of the California Voting Rights Act of 2001 (Chapter 1.5 (commencing with Section 14025) of Division 14 of the Elections Code) ("CVRA"), and the County Committee declares that School District's change in election method is being made in furtherance of the of the purposes of the CVRA; and

WHEREAS, having considered the proposal of the Board of Trustees of the Huntington Beach Union High School District to establish trustee areas and change the method of election to a by-trustee area election process as set forth in its Resolution No. 2-2023/24 as well as public comments, the County Committee recommends approval of the proposal of the Board of Trustees of the Huntington Beach Union High School District.

## NOW, THEREFORE, BE IT RESOLVED that:

- 1. The recitals set forth above are correct and true.
- 2. The Orange County Committee on School District Organization hereby approves the Huntington Beach Union High School District's proposal to:
  - a. Adopt by-trustee area elections, implementing the School District's trustee area boundaries map identified as Map Scenario A.
  - b. Assign the sequence of elections for the School District's five trustee areas as follows:
    - i. Trustee Areas 1 and 3 scheduled for election in 2024; and
    - ii. Trustee Areas 2, 4, and 5 scheduled for election in 2026.
- 3. The Orange County Committee on School District Organization hereby declares that Huntington Beach Union High School District's change to by-trustee area method of elections is being made in furtherance of the purposes of the CVRA and pursuant to Education Code section 5020(a)(2), Huntington Beach Union High School District's change to by-trustee area method of elections need not be submitted to the electors of the School District for approval. This resolution shall take effect upon adoption and shall govern all elections for governing board members occurring at least 125 days after adoption of this resolution.
- 4. Huntington Beach Union High shall submit the change in method of electing governing board members, trustee area boundary map, sequence of elections, and any other required information to the appropriate county elections officials, and to all other necessary parties by all required deadlines.
