## 2. The Single Plan for Student Achievement

- a. Plan of action to raise academic performance of all students to the level of performance established by the California Academic Performance Index. Education code and the federal Elementary and Secondary Acte require each school to consolidate all school plans for programs funded through the Consolidated Program Application process. (Title I, Title III, etc.)
- b. Our plan relates specifically to the funds and actions supporting the Youth Correctional Education Program. All community schools utilize the WASC action plan to guide their programs and utilize funding.
- 3. District English Learner (ELAC) Needs Assessment
  - 1. This document will be distributed at each A.U. ELAC to encourage parents to share ideas and expectations for the A. U. parent group
  - 2. Please review this and make suggestions as to additional items you would like included in the assessment
- 4. Guest speaker discussed the value of school attendance. Ms. Kelley McCarty, an ACCESS Outreach teacher works specifically with those students and families that struggle with school attendance. Each DELAC member received a single page explanation of our SARB process which Ms. McCarty discussed. Parents were offered an opportunity to ask questions specific to their needs and issues.
