ZOOM SOFTWARE RENEWAL IMPORTANT NOTICE

Please note the following responses to questions asked by prospective Proposers:

Question 1. Could you please provide me with your Zoom account number?

Answer: Our Zoom ID is 243367

Question 2. The bid docs contradict themselves regarding California State Sales Tax. Does this need to be included in the bid or not?

Answer: Sales tax is to be included if applicable. We will revise Paragraph 25 and 26 in the Information for Bidders Section.

Please make the following changes to Bid Number: 26-02:

1. Information for Bidders Paragraph 25 Pricing, has been replaced with the following:

Pricing. Pricing shall be set forth in the Bid Price Sheet. Prices must be stated for the unit items specified herein. Bid on each item separately. Charges for transportation, shipping, delivery, set-up, assembly, installation and handline of any containers shall be included on the Bid Price Sheet. No price increases will be permitted during the first (1st) year of the Agreement, after which prices quoted may be subject to adjustment (increase or decrease) in accordance with corresponding changes in the Consumer Price Index. The total price shall not be increased more than the Consumer Price Index for the greater Los Angeles/Riverside/Orange metropolitan area, as published by the U.S. Department of Labor, Bureau of Labor Statistics at : <http://www.bls.gov/cpi/>. If the unit price of any of the items on the price sheet are decreased anytime during the period of the Agreement, or should bidder sell the same equipment, materials and supplies under similar quantity and delivery conditions to the State of California or any public agency in the State of California, at prices below those specified on Bidder's Bid Price Sheet, SUPERINTENDENT shall be given the benefit of any lower prices which may for comparable quality and delivery be given by the Bidder to any public agency or any

other school district or any other State, County, municipal or local government agencies for the equipment, materials or supplies listed on bidder's Bid Price Sheet effective immediately upon the manufacturer's effective date of notice.

2. Information for Bidders Paragraph 26 Sales Tax, has been replaced with the following:

Sales Tax. If applicable, Bidder should include California State sales tax in Bid. Federal excise taxes are not applicable to schools districts, and shall not be paid by the SUPERINTENDENT.

This Addendum shall be considered part of the Project documents for the above-mentioned project as though it had been issued at the same time and shall be incorporated integrally herewith. Where provisions of the following supplementary data differ from those of the original Project Documents, this Addendum shall govern and take precedence.

Proposers are hereby notified that they shall make any necessary adjustments in their proposals on account of this Addendum. It will be construed that each Proposer's proposal is submitted with full knowledge of all modifications and supplemental data specified herein.
