1. Announcements

- a. Introductions
- b. AB1200 Fall Conference will be in October ESSCO to discuss ideas for presentations at the next ESSCO meeting on May 15, 2017. Please be prepared to share and discuss specific items you'd like addressed at the conference
- c. P-2 Certification property taxes and COE LCFF adjustments, NSS certifications and charter physical location are all due April 17th. Charter physical location adjustments must be submitted through a P-1 corrected file, and CDE should be notified that a corrected file has been submitted, as all physical location data are final as of P-2.

2. BASC Report

No BASC meeting since last ESSCO – BASC is this Friday

3. Basic Aid District of Choice

Current statute sunsets July 1, 2017. CDE will provide funding through 2017-18 if the program sunsets. AB 185 is an emergency measure to extend the Choice program but does not extend Basic Aid Choice ADA funding. If the bill passes the basic aid districts will NOT be funded in 2017-18. AB 185 proposes to extend District of Choice for six years. SB 52 proposes to extend the sunset date for five years – which allows Basic Aid Choice funding to continue.

4. Update on the ESSA per-pupil expenditure reporting requirement

The ESSA regulations that required States to develop a uniform method to determine LEA and school-level per-pupil expenditures to be reported in the State and LEA report cards, and that also specified the report card due date and the ability for States to apply for an extension of the due date, have been repealed. The CDE is in the process of determining next steps regarding guidance to provide to LEAs. It is possible that LEAs will have to report per-pupil school site expenditures for the 2017-18 school year report card.

5. ESSCO Accounting Subcommittee Update

Proposed language changes to EC 41372 were discussed. Chris will gather additional data points from the group and take to BASC this week.

- **6. PERS:** Are there any districts taking advantage of the prepaid option with PERS for the UAL portion of the employer contribution?
 - Option to pre-pay for the year ahead by July to receive a discount. Some districts considering borrowing to be able to pre-pay and get the discount. The option appears to apply only to "PEPR group A pool" although it appears most school districts are in that pool.
- 7. STRS on behalf rate calculation: What should be used for creditable compensation in the supplemental benefit maintenance account (SBMA) portion of the calculation? In making the calculation, I'm getting stuck on EC 22954(b): Except as reduced pursuant to subdivision (c), the total amount of the appropriation for each year shall be equal to 2.5 percent of the total of the creditable compensation of the fiscal year ending in the immediately preceding calendar year upon which members' contributions are based for purposes of funding the supplemental payments authorized by Section 24415, as reported annually to the Director of Finance, the Chairperson of the Joint Legislative Budget Committee, and the Legislative Analyst pursuant to Section 22955.5.

A number of members have attempted to back into last year's rate and calculate using the CalSTRS instructions but are unable to arrive at the same rate. This is most likely because CalSTRS used different amounts in their example calculation than what CDE used in its calculation. For example, when CDE calculated the rate they used creditable compensation from the second prior year. Discussion may carry over to the May ESSCO meeting.

8. Ending Fund Balance – Fair Market Value Adjustments

Discussion on how to post audit adjustments.

9. School-based Medi-Cal Administrative Activities (SMAA) Common Message

Many changes in the MAA programs, especially related to time studies. Also requiring re-reporting of prior quarters.

10. SELPAs

- a. Federal special education awards 3310 and 3320
 - The formulas for the federal awards shifted pupil counts from resource 3310 to 3320.
- b. How is enrollment and attendance reporting for special education pupils attending classes at other district handled?

There are many ways in which enrollment and attendance are captured. Education Code 56369 states that an LEA may contract with another public agency to provide special education or related services to an individual with exceptional needs.

c. Private school proportionate share reporting required for first time this year. Plan Type 20 comes from December 2015 pupil count but Plan Type 70 must be pulled from June 2016 count.
