**PROGRAM UPDATES**

- COVID Effects Update - During Pandemic:
  - 383 student appointments
  - 125 students enrolled
  - 75 students graduated
  - 238 students on current roster
- Social Media Marketing Campaign
  - Website inquiries increased over 200%
  - New Signage at 17th & Ross expected to generate new inquiries
- Computer Distribution and Connectivity - During Pandemic:
  - Distributed 291 chromebooks and 183 hotspots
- WASC Action Plan Goals

- Update on LMS Pilot
  - 117 courses were completed during pilot
  - Edgenuity, average course grade was “B” for 85% of students
  - Edmentum, average course grade was “B” for 82% of students
- Personnel Update
  - Academic Support Assistants - offers declined, new plan is to combine the two new ASA positions into one new Paraeducator position in July 2021.
  - Community Resource Specialist - offer was made, awaiting acceptance; first tasks will be to develop a matrix of county-wide resources and to engage students with partners. Will also create a class/workshop to assist with resume writing (OC Youth Center)
- iReady Assessment Intervention Matrices
  - Reading results improved by 62%
  - Math results improved by 50%

## BOARD DISCUSSION

- Expanded Learning Opportunities Grant
  - CCPA to receive \$214,179
  - Plan is to use these funds for personnel so that we bring as many adults in front of students as possible for additional learning opportunities.
