PLAN FOR PROVIDING EDUCATIONAL SERVICES TO ALL EXPELLED STUDENTS IN IRVINE UNIFIED SCHOOL DISTRICT

As required by Education Code 48926, the Orange County Superintendent of Schools has developed an expulsion plan in conjunction with the Superintendents of the school districts in Orange County. The plan provides for educational services to all expelled students in the county for school years 2024-2025, 2025-2026, and 2026-2027. A student whose behavior has resulted in an expulsion is provided a rehabilitation plan which ensures placement in an educational program and establishes the criteria for return to the Irvine Unified School District (IUSD). All educational alternatives provided by Orange County school districts are not available to all expelled students. The type of offense, location of offense, grade level and nature of the student's individualized needs; all have the potential to affect the educational alternatives available to the student during the period of expulsion. Students expelled for any of the offenses listed in subdivision (c) of Section 48915 of the California Education Code shall not be permitted to enroll in any district-operated program during the period of expulsion unless it is a community day school (E.C. 48915.2). Actual referral to a district alternative suspension/expulsion classroom or county community school is made by the Irvine Unified School District governing board with recommendations from the district administrative hearing panel, School Attendance Review Board (SARB), or by another established district referral process as required by statute.

As indicated in the Orange County Expulsion plan, the options available to Irvine Unified School District after an expulsion decision include, but are not limited to the following:

- 1. Expulsion, suspended order, with placement on the same school campus E.C. 48917 (a).
- 2. Expulsion, suspended order, with placement on a different school campus within the district E.C.48917 (a).
- 3. Expulsion with referral to a district community day school program, if available (E.C. 48660).
- 4. Expulsion with subsequent transfer to another district subject to acceptance by the district of proposed enrolment (E.C. 48915.1).
- 5. Expulsion with referral to the Orange County Department of Education, Division of Alternative, Community and Correctional Education Schools and Services (ACCESS) (E.C. 1981).

Summary of Gaps in Education Services to Expelled Students and Strategies for Filling Those Gaps:

Service Gap #1: While there are several California Education Code sections that prohibit the expulsion of students in lower grades for various offenses, a student in grade K-3 can be expelled for commission of any of the other offenses. Specifically, Education Code section 48900(k) prohibits the expulsion of any student for disruption/defiance and Education Code 48900.2 prohibits the expulsion of a student in K-3 for sexual harassment. Education Code 48900.3 (hate violence) and 48900.4 (harassment, threats, or intimidation) pertain only to students in grades 4-12. As identified mainly by elementary school and smaller districts, students in grades K-5 who are expelled do not have as many educational options available as do expelled youth in grades 6-12. In some instances, it has been difficult to place elementary school students who are expelled, especially at the K-4 level. The number of community day schools at the elementary school grade level is limited.

Description of Strategies for Filling Gap #1: Since 2021, there have been 0 students in grades K-5 that have been recommended for expulsion in IUSD. In the event a K-5th grade student is recommended for expulsion, there continues to be provisions in place to support these students. Depending on the specific infraction that lead to the expulsion, the first best step would be to suspend the expulsion order and transfer the student to another school within IUSD. If this is not feasible or would create a safety issue, IUSD would consider having the student attend the IUSD Virtual Academy (IVA) during the term of their expulsion. If this is not permitted under Ed Code based on the specific type of infraction, the district would consider the option to refer to Skyview.

Service Gap #2: The Orange County Department of Education is committed to expanded program options for students with exceptional needs that have been expelled from school district programs. As identified through communications with SELPA and District-Special Education Directors, programs for emotionally disturbed and dual diagnosis (Emotionally Disturbed and Developmentally Delayed) students have been developed in some school districts as well as the OCDE Special Schools program. In addition, ACCESS continues to evaluate its Special Education services to provide a continuum of placement options. When a student's unique needs cannot be accommodated through existing OCDE program alternatives, the district of residence will continue to facilitate placement to meet the unique needs of individual students through district and non-public agency/non-public school (NPS) placements.

Description of Strategies for Filling Gap #2: When students with disabilities are referred for expulsion, the Student Services Department works collaboratively with the Special Education Department to determine the unique programming needs. We utilize a continuum of options and always start with the option of suspending the expulsion and transferring the student to another school within the District. Depending on the level and types of services the student receives, IUSD considers a referral to ACCESS. Communication with ACCESS is done prior to the pre-expulsion meeting to ensure that ACCESS would be able to accept the referral before offering this option to parents. ACCESS reviews the student's IEP and notifies the District if a referral would be possible. If ACCESS is not an option, the District works to secure a placement at a non-public School (NPS) during the duration of the expulsion.

Service Gap #3: Based on the most recent survey of Orange County school districts, concerns about students failing to satisfy school district rehabilitation plans during the expulsion period were expressed in combination with general concerns about student transition as they reenter the district. On occasion, students do not meet the provisions of the expulsion rehabilitation plan and fall behind in their academic studies. In these cases, such students are at high risk of not completing their necessary credits and are at a higher risk of dropping out of school.

Description of Strategies for Filling Gap #3: During a pre-expulsion meeting or following an expulsion hearing, the Director of Student Services reviews the rehabilitation plan with the student and their parent/guardian. To eliminate barriers, IUSD has created a one-page resource guide that is provided to the student and family to help facilitate the completion of the items from the rehabilitation plan. When the expulsion order is expired and the student is safely able to return to the District, the Director of Student Services meets with the student and family, as well as a site administrator from the school the student is expected to return to, for a re-entry meeting. At the re-entry meeting, the contents of the rehabilitation plan are reviewed to ensure the student is ready and able to return safely to the school. If certain components of the plan were unable to be completed, the team will determine if there were certain barriers that prevented the completion of the requirement and decide if exceptions can be made or alternative arrangements put into place to allow for the student to return to school. One area of growth since the last expulsion plan in this area is closer communication with the family throughout the term of the expulsion to ensure adequate progress is being made toward meeting requirements. Additionally, the District has entered into a contract with California Youth Services and funds all referrals made to the Juvenile Alcohol and Drug Education (JADE) program.

Service Gap #4: Orange County School Districts are experiencing an increased need for mental health services and a shortage/lack of affordable and accessible options for students.

Description of Strategies for Filling Gap #4: Mental health continues to be a significant area of need for IUSD students. As such, IUSD has established several activities, programs, and services to address the mental wellness of all students and families. When a student is referred for expulsion, there is often a mental health component required as part of the rehabilitation plan. Often times, students are required to complete a prescribed amount of counseling sessions. In certain cases, specific programs are recommended, including the "Pathways" program through California Youth Services. When general counseling is recommended, the District makes a referral to "Care Solace," which is a mental health concierge services that helps link families and students to specific therapists, counselors, or mental health specialists to meet the specific and unique needs of the student being referred. Additionally, IUSD has contracted with "Everfi," which offers a variety of restorative practices and modules that are completed independently by students to address a variety of needs, including mental health and wellness. Completion of Everfi courses are often required of students either as an alternative to suspension or as part of their rehabilitation plan thorough an expulsion order. Other mental health and wellness programs that IUSD utilizes include behavior assemblies, SEL lessons including Second Step, PBIS methodologies, the use of restorative practices, mental health toolkits for administrators, teachers, and parents, and individualized mental health counseling.

48926.

Each county superintendent of schools in counties that operate community schools pursuant to Section 1980, in conjunction with superintendents of the school districts within the county, shall develop a plan for providing education services to all expelled pupils in that county. The plan shall be adopted by the governing board of each school district within the county and by the county board of education.

The plan shall enumerate existing educational alternatives for expelled pupils, identify gaps in educational services for expelled pupils, and strategies for filling those service gaps. The plan shall also identify alternative placements for pupils who are expelled and placed in district community day school programs, but who fail to meet the terms and conditions of their rehabilitation plan or who pose a danger to other district pupils, as determined by the governing board.

Each county superintendent of schools, in conjunction with the superintendents of the school districts, shall submit to the Superintendent of Public Instruction the county plan for providing educational services to all expelled pupils in the county no later than June 30, 1997, and shall submit a triennial update to the plan to the Superintendent of Public Instruction, including the outcome data pursuant to Section 48916.1, on June 30th thereafter.
