### **Grant Specifics:**

 Engage in coaching to support implementation of the CA MTSS Framework and completion of the CA MTSS Pathway Certification for Schools course with a focus on building or enhancing the social-emotional well being of youth using Universal Design for Learning, Trauma Informed Practices

- and Culturally and Linguistically Relevant and Responsive Teaching practices.
- Goal of 90% of school staff to complete the CA MTSS Pathway Certification for Schools course during the 24month window (including administrators, teachers, school counselors, school psychologists, paraeducators, and school-based mental health clinicians) (course completion ETA: 40-60 hours)
- Gather and submit data, including, but not limited to: Fidelity Integrity Assessment, Schoolwide Implementation Tool, attendance, discipline, school climate and perception surveys

# **Application Types and Award Amounts for Individual Schools**: (for new applicants not currently involved in Phase 3)

- Apply as an individual school: \$50,000 for schools with up to 1,000 students
- Apply as an individual school: \$100,000 for schools over 1,000 students

Funding will be used for stipends/release time for educators to participate in and complete the CA MTSS Pathway Certification for Schools course during the grant phase. Funds must be encumbered by June 30, 2025 and expended by March 30, 2026.

Priority will be given to schools that agree to having at least 90%

of their staff complete the CA MTSS Pathway Certification for Schools course. Estimated course completion time frame: 40-60 hours beginning March 2023 - March 2025.

Priority will also be given to schools within local educational agencies serving a high number of unduplicated pupils and to schools in districts which have had prior experience with CA MTSS district foundations training either through the CA SUMS Phase I training or through subsequent training provided either by their County or District office.


