As you are aware, the Orange County Department of Education (OCDE) houses the official National Training Center (NTC) for the Project GLAD® training model and has done so for over a decade. The OCDE Project GLAD® National Training Center, Project GLAD® trademarks, and Project GLAD® program were transferred to OCDE from Fountain Valley School District (FVSD). Since assuming sole responsibility for the Project GLAD® training model, OCDE has remained true to the core training model principles while expanding efforts to incorporate the most current research and address emerging instructional needs for schools in California and throughout the country.

The OCDE Project GLAD® National Training Center has received communications from colleagues in the field expressing confusion about the independent training programs offered by Noshaba Afzal and Jabbar Beig and their companies, Bay Area GLAD, LLC and BE GLAD LLC (collectively the "Bay Area GLAD Parties"). As you may be aware, there was a lawsuit between OCDE and the Bay Area GLAD Parties. OCDE is pleased to report that all matters have been amicably concluded through an agreement between the parties and the lawsuit dismissed.

As part of the agreement, OCDE has granted Bay Area GLAD Parties a license to use OCDE's GLAD<sup>TM</sup> and Project GLAD® trademarks in connection with a distinctive designation of their separate unaffiliated programs, a "source identifier" distinguishing them and their programs from the OCDE NTC. Going forward, all OCDE NTC activities involving GLAD<sup>TM</sup> and Project GLAD® will always be identified as being from OCDE or the NTC, generally and to distinguish the OCDE NTC from the Bay Area GLAD Parties. In turn, the Bay Area GLAD Parties have agreed and will do the same as to any training programs they conduct to distinguish them from the OCDE NTC. These distinctions will help avoid confusion in the future.
