Special Education Preschool



Requirements: 3-5 years old and lives within that specific District attendance area

Parent/Guardian Initiated Referral

- Place concerns in writing & submit a letter to their District of Residence
- The letter should include Attention: Special Education Department
 - Address verification, birth certificate, immunization record, and their District's Preschool Referral Form
- The District will mail a PWN to the parent/guardian that includes Parent Rights
- The District will send a copy of the PWN and copies of all the forms that the parent/guardian submitted to the Preschool team
- The District Preschool team will contact parent in order to schedule an intake meeting
- If an assessment is determined necessary, the parent will be provided with an assessment plan & District enrollment packet

<u>Transition from Regional Center to</u> <u>School Based Services</u>

- Regional Center may service students from 0-3 years old
- Refer students prior to his/her 3rd birthday to their District of Residence
- Assessment to determine if the student qualifies for school-based services
- Regional Center representative may contact the District's Preschool Psychologist
- District Preschool Psychologist will connect with parent/guardian in order to provide an assessment plan & District enrollment packet





- IEP Transition meetings may be scheduled in mid-Spring
- The IEP meetings are called "Kinder Transitions"
 - o Formal assessments are included
- At the IEP meeting, the FAPE offer will be discussed
 - Goals drive services
 - Services drive placement
- Depending on the District, special education placement/programs may be spread out at various school campuses
- Please check with your District if program tours are available

Elementary to Middle School

- IEP Transition IEP meetings are typically held in May
- IEP teams will schedule these meetings for all students that are transitioning into Middle School
 - Depending on the District's middle school programs that may be for 4th graders and/or 5th graders transitioning up
- All IEP team members including related service providers are invited to the meeting
- Both the Elementary and Middle School teams will present information
 - Discuss the similarities and differences between both programs/campuses, bell schedules, and will update service minutes if needed
 - Discuss big changes such as PE and electives

Middle School to High School

Districts start to collaborate late January/February



- FJUHSD School Psychologists complete student observations at the elementary Districts
- During the observations, Districts are discussing comparable programs for the IEP teams to consider
- 3. Districts will block out 2-4 weeks to complete all IEP meetings
 - a. IEP meetings are now held in person
 - b. Please refer to your District if zoom is an option
- 4. IEP documents are sent via email to all IEP team members
- 5. Elementary District clerks mail the students' special education files in the summer to FJUHSD
