Subject: UPDATED 2023-2024 Employer Payroll Expense Rates

The following is an estimate of 2023-24 payroll expense rates based on the most recent information available. Please note the inclusion of the 2024 IRS standard business mileage rate, which increased to 67 cents (from 65.5 cents). We are expecting a change in the CalPERS Maximum Wage Limits within the next few weeks. Further memos will be distributed as rate information becomes available.
