Subject: **Updated 2024-25 Employer Payroll Expense Rates** 

The following is an estimate of 2024-25 payroll expense rates based on the most recent information available. Please note the updated CalPERS wage limits in effect for calendar year 2025. While CalPERS sets contribution rates by fiscal year, wage limits are updated by calendar year. CalSTRS sets both rates and wage limits by fiscal year; there are no changes to CalSTRS rates at this time. Further memos will be distributed as rate information becomes available.
