### ***Mental Health Services Act Prevention and Early Intervention Program Planning***

The Mental Health Services Act (MHSA), approved by voters in 2004 as Proposition 63, requires that each county in California prepare a Prevention and Early Intervention (PEI) program plan. The County of Orange Health Care Agency wants to know what you think about services to be offered and groups of people to be helped by mental illness prevention and early intervention programs in Orange County.

The *prevention* element of the PEI program is meant to reduce risk factors or stressors to prevent the initial onset of a mental health problem as well as promote and support the well-being of “at-risk” individuals under challenging life circumstances in order to reduce the suffering associated with mental health problems.

The *early intervention* element of the PEI program is designed to prevent a mental health problem from getting worse. These programs are directed toward people for whom a short-duration (1 year), relatively low-intensity intervention is appropriate to measurably improve mental health problems or to avoid the need for more extensive mental health treatment.

## Children Now gives California another “C”



California’s children did not fare much better in 2007 than they did in 2006, according to Children Now, a nonpartisan, nonprofit children’s advocacy organization. The group cited poverty and poor health and education status as key problems for policy makers to address. They called on state leaders to increase funding and implement policies to improve children’s well-being.

Of the nine and a half million children in California, one in five lives in a very poor home, according to the report. Fewer than half of families earn enough to cover the costs of housing, child care, food and health insurance.

Children Now measured different elements of children’s welfare in three broad categories: health, including health insurance and mental health; education, including early care and education and after-school programs; and “cross system issues,” such as obesity and child safety. California received a “C” in both health insurance and mental health. “Despite their promises,” the group reported, “state lawmakers did not improve children’s access to health insurance in 2007.” In fact, they declared, funds for outreach programs for public health coverage, such as Healthy Families, were cut. The group said the number of uninsured children in the state has remained unchanged since 2003, and California ranks 43<sup>rd</sup> out of 50 states in that category.

California’s education grade also averaged a mediocre score. While Children Now found improvement in children’s test scores, it declared that high school graduation rates “remain unacceptably low.”

There was no change in the grade Children Now gave California for early care and education over the last two years. While nearly all parents appear to agree that preschool is important for children, only about one half of three- and four-year-olds attend. The group attributed this gap to an inadequate capacity. Further, “The children most likely to lack access to high quality preschool are those who would benefit from it the most.”

California received a higher mark for after school programs, which got a “B+.” According to Children Now, the number of public school programs in elementary and middle schools doubled and high school programs quadrupled. ## California Per Pupil Expenditures

**Education Week** ranks California **46<sup>th</sup> in ADJUSTED** per pupil expenditures of **\$7,081** as compared to the national average of \$8,973. **The adjustments are for regional cost differences** (based on 2004-05 data).

**National Education Association (NEA)** ranks CA **29<sup>th</sup>** in per student expenditures of **\$7,942**. Note that this is different from Education Week’s figures because **regional cost differences are not accounted for** in NEA’s calculation (based on 2004-05 data).

The Governor’s May Revise 2008 K-12 Budget shows Proposition 98 per pupil spending of **\$8,509 in 2007-08** and **\$8,610 in 2008-09**.

We sometimes hear or see in the press per pupil education spending of **\$11,935 for 2007-08**. This figure is the per pupil education spending from **all funding sources**; it includes funds for CDE state operations, prior year settle-up obligations, state special schools, state school facilities, bond repayment, state contributions to the State Teachers Retirement System, the State Library, and the Commission on Teacher Credentialing.
