A Message from the OCSBA President – Suzie Swartz

Most often the expression a “gaggle of geese” brings to mind a large, noisy gathering of people. There are, however, important lessons to be learned from geese. Here is what science has discovered about geese flying in their famous “V” formation:

- As each goose flaps its wings, it creates uplift for the bird immediately following. By flying in “V” formation the whole flock adds at least 71% greater flying range than if each bird flew on its own.
- When a goose falls out of formation, it suddenly feels the drag and resistance of trying to go it alone and then quickly gets back into formation to take advantage of the lifting power from the bird in front.
- When the lead goose gets tired, it rotates back in the wing formation and another goose flies point.
- Geese honk from behind to encourage those up front to keep moving forward, to keep up speed.

Finally, and this is important:

- When a goose gets sick or is wounded and falls out of formation, two other geese fall out and follow down to lend help and protection.

What is good for the goose is good for the school board member – we must stand together with purpose and focus on our goal to provide the best education possible to our students despite these dire economic times. We can still take advantage of learning opportunities from each other’s experience and perspective. We can still encourage and uplift one another to help our students weather this financial crisis. I do believe that through OCSBA and the sense of community, we can build upon with our administrators, teachers, parents and school employees, we can increase our range of success to secure education funding and propel our schools forward.

Finally, just as we strive to ensure that no child falls through the cracks, we should have the good sense of geese and stand by each other, too.

I look forward to seeing you on May 25.


Sharon Wallin & Meg Cutuli

7 Orange County Schools Named State's Best



The California School Recognition Program is now in its 25th year and honors the state's most exemplary and inspiring public schools with the California Distinguished School Award. The prize, which alternates each year between elementary and secondary schools, goes to just 10 percent of campuses in the state. On April 12, 2011, State Superintendent of Public Instruction Tom Torlakson announced the 99 California public middle and high schools selected as 2011 California Distinguished Schools. "These schools are being recognized for attaining high levels of performance and sustained growth, and for making significant progress in closing the academic achievement gap," Torlakson said. "Becoming a Distinguished School is a direct reflection of the dedication, hard work, and vision of each school's education community. They have succeeded despite a bleak economic environment and have endeavored to maintain their momentum and focus."

Seven Orange County public secondary schools were named 2011 California Distinguished Schools. This year's Orange County winners are: Oxford Academy, Anaheim Union High; Brea-Olinda High, Brea-Olinda Unified; Ladera Ranch Middle, Capistrano Unified; Newhart Middle, Capistrano Unified; Santiago Middle, Orange Unified; Col. J. K. Tuffree Middle, Placentia-Yorba Linda Unified; and Arnold O. Beckman High, Tustin Unified.

Schools selected as California Distinguished Schools agree to share their Signature Practices that have provided the foundation for exemplary performance related to the Academic Performance Index (API) and Adequate Yearly Progress (AYP) results and serve as mentors to other educators who want to replicate their work.
