

**The message in Spencer Johnson's
"Who Moved My Cheese"
reveals profound truths about change.**

As I re-read this short simple parable I realized that all of the conclusions described in "The Handwriting on the Wall" apply to board members. The suggestions might help you reduce your stress and enjoy more success in your work and life. Whether you are a veteran or new board member, participation in OCSBA can help you with this process.

No question that change happens in life and in school districts. However, by anticipating change and preparing for the "cheese to move" you reduce the stress and prevent crisis. November Ballot Set: Proposition 47 Key to School Facilities

Three initiatives of interest to the education community on the November ballot are:

- **Proposition 47— Kindergarten-University Public Education Facilities Bond Act of 2002**
A \$13.05 billion bond act for school facilities, with \$11.4 billion ear-marked for K-12 facilities construction and modernization, with the balance utilized for higher education facilities.
- **Proposition 49 — After-school Programs**
To increase state funds available for: before-and after-school programs which provide tutoring, homework assistance, and educational enrichment. The proposition would accomplish this by ear-marking a specified portion of Proposition 98 funds (over and above Proposition 98 base funding) for these state grants.
- **Proposition 51 — Transportation Allocation of Sales and Use Taxes Raised from Sale or Lease of Motor Vehicles**
To dedicate 30% of all sales tax revenues collected on vehicle sales and leases to a Traffic Congestion Relief and Safe School Bus Trust Fund. The measure would direct those funds to specified projects and programs targeting highway and transit improvements, including school bus replacement.



Speakers:

Frank McCourt: Born in Brooklyn and raised in Ireland. Frank McCourt returned to the United States as a young man and became a teacher, working in the New York City public schools for 27 years. His childhood memoir, *Angela's Ashes*, won the Pulitzer Prize in 1997 and was made into a movie in 1999. McCourt's follow-up, *Tis: A Memoir*, was also published in 1999.

Maria Hinojosa: Born in Mexico City, award-winning journalist and author. Maria Hinojosa became the first CNN correspondent assigned exclusively to report on urban affairs. Hinojosa also anchors National Public Radio's Latino USA, reporting on news and culture in the Latino community. Hinojosa's critically acclaimed memoir, *Raising Paul: An Adventure Raising Myself and My Son*, was published in 1999. Hinojosa earned a bachelor of arts in Latin American studies, political economy and women's studies at Barnard College.

Dr. Freeman Hrabowski: Freeman A Hrabowski, III, president of the University of Maryland, Baltimore County was recently elected to the American Academy of Arts and Sciences. He has received the McGraw Prize in Education and The U.S. Presidential Award for Excellence in Science, Mathematics, and Engineering Mentoring. He is co-author of two books: *Beating the Odds* and *Overcoming the Odds*, which focus on the successes of young African American men and women in the field of science. Dr. Hrabowski was prominently featured in Spike Lee's 1997 documentary, *Four Little Girls*, which told the story of the racially motivated 1963 bombing of Birmingham's Sixteenth Street Baptist Church.

A Tribute To

BENNY HERNANDEZ

The Anaheim Union High School District (AUHSD) and the Orange County School Boards Association (OCSBA) suffered a loss with the death of Benny Hernandez. Benny was elected to AUHSD Board of Trustees in November 2000. Despite his major health challenges, he enthusiastically fulfilled his responsibilities as a board member, and provided encouragement and assistance for all students. He had recently been appointed to represent the high school districts on the OCSBA Board.

His dedication to the community was displayed in service on KinderCarminata, Healthy Families Steering Committee, and the Southern Anaheim Neighborhood Council where he taught parenting classes and started the Homework Club at Ponderosa Park.

FOOD FOR THOUGHT

Most board members are aware of the complexities associated with school funding to districts. One inequality exists for 7th and 8th graders.

- The elementary school districts have their junior high programs funded at the lower elementary revenue limit.
- The unified districts' 7th and 8th graders are funded at the unified revenue limit which is greater than the elementary school amount.
- High school districts that include 7th and 8th graders are funded at the high school revenue limit which is greater than the elementary and unified revenue limit.

Assemblywoman Lynn Daucher is attempting to increase the revenue limit paid to elementary districts' 7th and 8th graders to equal the amount funded to unified districts.

WHO IS THE COUNTY NOMINATING COMMITTEE?

■ **WHAT IS THE NOMINATING COMMITTEE AND WHY ARE THEY MEETING?**

Each district in the county has a board member who represents a district on the County Nominating Committee. They meet once a year to elect members to the Orange County Committee on School District Organization. It is very important to have a quorum at this meeting that will be held before the first OCSBA/ACSA dinner meeting of the year.

■ **WHO IS THE ORANGE COUNTY COMMITTEE ON SCHOOL DISTRICT ORGANIZATIONS?**

This committee is composed of two representatives from each of the five county supervisorial districts and one at-large member. They serve as a central initiator, coordinator, facilitator and arbitrator for the reorganization of school districts.

■ **IN WHAT WAYS ARE DISTRICTS REORGANIZED?**

This past year, the committee had hearings in most of the community college districts to approve changes in trustee voting areas due to the census report. Elementary or high school districts can be unified. Several Orange County K-12 districts had territories transferred from one district to another. These changes should not be harmful to the districts in regards to enrollment, community identity, property and facility division, racial and ethnic distribution, state costs, educational programs, school housing costs, property values and fiscal status, but do require thoughtful consideration.

■ **WHO CAN INITIATE A CHANGE IN SCHOOL ORGANIZATION?**

By current law, citizen groups, city councils, or county boards of supervisors can submit a petition for unification or other reorganization. However, AB 2254 (Salinas) in the current Assembly session would allow an individual district board to submit such a petition. This has the possibility of straining district relationships.
