OC JUVENILE JUSTICE COMMISSION

The Orange County Juvenile Justice Commission (JJC) is a group of private citizens appointed by the Superior Court with the concurrence of the Juvenile Court and authorized by Welfare and Institution Code Sections 225-231. The mission of the JJC is to inquire into the administration of juvenile court law in this county and to ensure that the highest standards of care and services are maintained for the youth within the juvenile justice system. The JJC advocates for a compassionate and collaborative community to meet the mental, physical, and educational needs of system-involved youth.

COMMUNITY OUTREACH: The Essay Contest

In 2018, the Juvenile Justice Commission (JJC) introduced an essay contest to encourage students to express themselves while they were at the Otto A. Fischer School at Juvenile Hall and the Youth Leadership Academy; the Rio Contiguo High School at the Youth Guidance Center; and the William Lyon School at Orangewood. The contest was so well received that it was held again in September, 2019, but was limited to students grades 9-12 at Juvenile Hall and the Youth Guidance Center.

In collaboration with the Probation Department, the Orange County Department of Education (OCDE) and the Orangewood Foundation, the contest presented awards to three winners and nine honorable mentions. Each recipient also received a gift card, a writing journal and a certificate.

The teachers provided the guidance for the students to complete their submissions. The essays were judged according to a rubric by a panel selected by the JJC. An awards ceremony was held at Juvenile Hall where the winners read their entries in front of an audience that included family members as well as representatives from Probation, OCDE and Juvenile Court.

Altogether, there were 43 participants who contributed to the contest that was entitled 'Just Saying'. The essays, which were extremely profound and reflective, provided the students an opportunity to put their ideas, thoughts, and feelings into words. The project proved to be self-empowering, giving participants a voice during a difficult time in their lives.

The JJC would like to thank the Orange County Superior Court Judges, the Probation Administrators, and the OCDE Teachers / Administrators (especially Kirk Anderson and Ruth Ramirez). The JJC would also like to thank the Orangewood Foundation for generously underwriting the project. Most of all, the JJC would like to thank the brave youth who shared their experiences and insight while in custody.

COMMUNITY OUTREACH: The *Power of One* Video



We can all agree that one of the most powerful motivators is hope. This year, the Juvenile Justice Commission, in partnership with Probation, developed a short video featuring Dr. James Maciel titled "The Power of One". (<https://www.youtube.com/watch?v=kHQ2z3gBt9g>) This video shared the amazing story of a young man who despite spending time incarcerated in both Juvenile Hall and the Youth Guidance Center was able to turn his life around and put himself through college to become a UCLA trained physician.



The video was created by the talented Melissa Murphy and has been shared with various units in Juvenile Hall as well as the Youth Reporting Center. We were fortunate to have Dr. Maciel attend the presentation of the video in Juvenile Hall where he reflected on the part key role models, like Officer Elizabeth Vazquez, played in his life as well as shared words of encouragement with current probation youth.

INSPECTIONS OF COUNTY-ADMINISTERED JUVENILE INSTITUTIONS

Each year the Juvenile Justice Commission, as mandated by the Welfare and Institutions Code, inspects the four facilities that provide residential care and services for those children/youth who are part of the Juvenile Justice System. The purpose of the inspections is to ensure that high quality and appropriate care is being provided. Each of the facilities provides an accredited school program staffed by the Orange County Department of Education so that education is not interrupted by the time in residence. Each facility also has medical staff on site to address any medical needs. Children and youth also have access to behavioral health care.

Orange County Juvenile Hall

Announced Inspection: October 23, 2019

This Probation-run, maximum security facility houses male and female youth who have committed serious offenses in the community. Besides participation in the on-grounds school, programming includes Anger Management, Substance Abuse classes, and Conflict Resolution among others. Family Reunification and one-on-one counseling are important aspects of the program. During the inspection there were no items requiring corrective action.



One of the opportunities available to the youth in the facility was a program put on by the Young Americans which included both performances by them and a joint performance by the professionals and the youth. The Commission commends the staff and administration for providing such an opportunity for the youth in residence.

Youth Leadership Academy

Announced Inspection: September 18, 2019

This Probation program is a semi-secured camp facility for teenage males and was designed as a short-term stay program that focuses on a smooth transition back into the local community. The program provides individual therapy sessions which address substance abuse, gang prevention and aggressive behavior. There are also group therapy sessions and family and crisis counseling sessions available.

These youth attend school on-grounds.

There were no corrective action items identified in the inspection this year.





Youth Guidance Center Announced Inspection: May 1, 2019

The Youth Guidance Center (YGC) is a Probation facility and has four dormitories, a gymnasium, and outdoor fields. There are both male and female residents generally ages 14-18. The primary focus of this program is on substance abuse. Youth attend school on-grounds and also receive college and career readiness and occupational skill assistance.

The Commission requested repair to a drainage issue in the males' bathroom. The Commission commends the facility for encouraging youth to participate in Segerstrom Center's Summer at the Center, giving youth the opportunity to perform. Commissioners enjoy attending those performances and seeing what a positive experience they are for the youth.

Orangewood Children and Family Center Announced Inspection: April 10, 2019

This campus of cottages run by Social Services houses children/youth who are Dependents of the Court. As a result of recent legislation the length of stay is targeted to be 10 days or less. These children are awaiting placement, either back with their parents, or with other caretakers. They came before the Court as a result of abuse and/or neglect and the goal is to insure they return to a safe home. The Center is a cottage style campus with younger children housed separately from older youth. There is a school program provided as well as various on-grounds activities. In addition, mental health services are available on campus.

While the facility was in good order and repair overall, the Commission requested some repairs in a bathroom and cleaning of air vents.

The Commission was pleased to be able to work with the Administration of the facility to increase the residents access to and use of their cell phones while in care.



INSPECTIONS OF OC LAW ENFORCEMENT AGENCIES

The JJC is mandated by State law to inspect all law enforcement facilities where a minor is held in secure detention for any length of time and those where a minor is held in non-secure detention for 24 hours or more. No facility, other than the Probation-run institutions, holds minors for more than 24 hours. The JJC exceeds state law mandates by inspecting all facilities where a minor is held in non-secure detention for 6 hours or more. Listed below are all OC law enforcement facilities operated by police or sheriff departments with their recent statistics on detention of minors. 2019 inspection dates are listed for those that met inspection criteria. The JJC inquired about topics such as human trafficking of minors, the role of School Resource Officers, community youth programs, and interactions with Probation and Social Services.
