This memo is being submitted to provide you with a detailed explanation of our 2016-17 property tax revenue estimates for schools.

Type Tax Revenue

- 1. <u>Secured</u>: 99.0 percent of initial local tax charges plus 99.0 percent of 2016-17 State Assessed Properties Levy plus 2015-16 Area-Wide actual tax revenues. (The J-29 instructions from the Property Tax Software indicate that secured taxes also include areawide taxes.)

- 7. Release of Impounds: Zero
- 8. <u>Homeowners Subvention</u>: Estimate equals actual of 2016-17 Homeowners Exemption Claim filed on October 2016.
- 9. Timber Tax: Estimate equals actuals received in June 2016.
- 10. <u>RDA Statutory Pass-Through Revenue Limit Share</u>: Estimated 2016-17 Statutory passthrough payments revenue limits (K-12 = 43.3% and COE = 19%)

- 11. <u>RPTTF Residual</u>: Estimate equals to actual residual on the January 3, 2017 RPTTF distribution plus estimate on the June 1, 2017 RPTTF distribution.
