### 2.0 North Orange County Special Education Local Plan Area Office Space

#### 3.0 2023 Governor's Proposed Budget

Dr. Robin Gilligan discussed the funding for the NOC SELPA that is calculated based on ADA.

The highest ADA year that is currently used in this calculation will be dropping off in 2023-2024, and Local Education Agencies (LEAs) will need to prepare accordingly for the new ADA level. More details about the potential impact will be known after P-2 ADA is certified and the May Revision of the 2023 Governor's Proposed Budget is released.

#### 4.0 Annual Determination Letters

CDE will be sending out the Annual Determination letters on March 20, 2023. Dr. Robin Gilligan shared a presentation on Special Education compliance areas, levels, compliance plan timelines, and alignment with the state's Differentiated Assistance monitoring process.

### 5.0 Above and Beyond Award Celebration Update

Dr. Robin Gilligan shared the names of the 2022-2023 Above and Beyond Award recipients.

The six recipients for this year are Sara Tarne from Buena Park School District, Jill Chapman from Fullerton School District, Marta Toth from Fullerton Joint Union High School District, Whitney Reeve from La Habra City School District, Rachel Coleman from Lowell Joint School District, and Carey Williams from the Orange County Department of Education.
