# **RACE TO THE TOP**

Race to the Top (RttT) is authorized under the American Reinvestment and Recovery Act (AARA). Funded by Congress it is the largest amount of

discretionary money ever dedicated to education reform. It will be directly tied to four key areas of reform as outlined by the Department of Education:

- adopting internationally benchmarked standards and assessments that prepare students for success in college and the workplace;
- recruiting, developing, rewarding, and retaining effective teachers and principals;
- building data systems that measure student success and inform teachers and principals how they can improve their practices; and
- turning around our lowest performing schools.

States that receive a Race to the Top (RttT) grant must use at least 50 percent of the funds to provide sub grants to local educational agencies (LEAs), including charter schools, based on their relative share of Title I funding. The remaining funds are available to the State for state level activities and awards to LEAs and other entities through the use of formulas or competitive grant processes. LEAs that choose to participate in their State's RttT proposal must agree to use their funding to support the State's plan.

California submitted its RttT application January 19, 2010. The first round of grants to states is expected to be announced in April 2010. States are required to share Race to the Top funding with school districts. A second round of applications will be taken in June 2010 and final awards will be made in September 2010.

The President's 2011 budget will include additional funding for Race to the Top grants to states and local school districts. The President has already called for an additional \$1.3 billion in funding for Race to the Top and that is expected to be a recommendation in the Administration's 2011 Budget proposal.


### "Building a Generationally-Friendly Learning Community"
