Time to Take Action!

Ask Your Local Legislators to Keep Their Promises to California Students

In the coming weeks, Orange County partners in the Education Coalition, including CSBA, ACSA, CCESA, CSEA, CTA, CFT, AFT and CASBO will be meeting with local legislators in their home offices to talk about what's happening in our local schools as a result of the devastating statewide budget cuts.

Over the last two years, more than \$17 billion has already been cut from education. We rank at the very bottom nationally in staff-to-student ratios and nearly last in perpupil spending. Libraries have been virtually wiped out, while arts, music, sports,

The Marian Bergeson Award recognizes an Orange County School Board member who has provided outstanding governing board service and community service to promote and enhance

public education. The award serves as a tribute to Marian for her exemplary leadership.

The 2009-2010 Marian Bergeson award recipient is Dr. John "Jack" Bedell. A dedicated educator, Dr. Bedell joined the Orange County Board of Education (OCBE) in July, 2003, filling a vacancy for District 4, representing

Buena Park, Fullerton, La Habra, Placentia, and portions of Anaheim. The following year, he was elected to the Board for his first four-year term.

Jack is passionate in his commitments to ensuring the achievement of all students and the well-being of our communities. A proponent of local control, Jack is vigilant in his advocacy activities at the local, state and national levels. He regularly travels to meet with our Orange County legislative contingency in Washington, D.C. to advocate for adequate IDEA funding, and to ensure the rights of local school boards are protected. He and his Orange County Board of Education colleagues were instrumental in ensuring schools continued ability to claim Medicaid funding for Medi-Cal Administrative Activities (MAA).

Jack has been a career educator and sociologist for more than forty years at CSUF, where he is a Professor of Sociology. He is a person of great knowledge and passion for teaching. During his years at CSUF, Jack has chaired the Academic Senate for five terms and served several terms as Chairman of Sociology, Child Development, Electrical Engineering, and currently serves as Chairman of the Anthropology Department. He also served as Director of the Faculty Development Center as well

advanced placement and other essential programs have been eliminated from the curriculum in some districts.

It's time to remind lawmakers that our public schools have been subjected to 60 percent of the budget cuts, even though education funding is only 40 percent of the statewide budget.

It's time for them to keep the Legislature's promise to our students and sign the Commitment Card to uphold the budget agreement that was signed into law. The Commitment Card says that your legislator will:

- Protect public education funding from further cuts,
- Stand by the budget agreement signed into law (AB 4X 3) to restore \$11.2 billion in funding owed to schools and community colleges, and
- Oppose any attempts to suspend or undermine Prop 09, the voter-approved minimum school funding guarantee.

News Flash? California Expenditures Per-Pupil Among the Lowest in the Nation

It will come as no surprise to anyone familiar with California's Budget woes, that California's spending per student is officially among the lowest of all states. Two recent reports show that California has fallen from being

below average in spending per student to far below average.

In the **NEA**'s *Rankings and Estimates: Rankings of the States 2009 and Estimates of School Statistics 2010*, California was ranked 44th in spending per average daily attendance (ADA) in 2008-09. The report noted that California's expenditures per ADA were approximately \$8,605, compared to the national average of \$10,736 (a gap of \$2,131 per student).

The *Education Week* annual review, the *Quality Counts* **2010** reports financial data from school year 2006-07, which for now stands as the high watermark in California spending on education.

The *Quality Counts* report found that, even at a relatively high point in spending, when adjustments for regional cost differences are applied, California ranked 46th among the 50 states and Washington, D.C., with an adjusted expenditure level of \$8,164 per student compared to the national average of \$10,557 per student. It stands to reason that comparisons for subsequent years will show California dropping further down in the rankings and the gap with other states growing.

It is heartening to note that, in spite of our relatively low spending when compared to other states, California's student performance is about average. In this regard, it appears that California may be among the lowest-funded school systems in the country, but is achieving an above-average result considering the level of investment.
