A Message from the OCSBA President – Sue Kuwabara

The California School Boards Association promotes excellence in education by annually recognizing outstanding programs in school districts and county offices throughout California with a Golden Bell Award. Districts in Orange County receive many of these awards each year. I have enjoyed the honor of serving as an evaluator for the program finalists in our County for the last three years. Each year, I have walked away with an appreciation of the commitment districts in Orange County have to serving their students' needs.

It's exciting to see strong programs that could be of value to my district, and to talk to other evaluators that share my enthusiasm. Of the many programs evaluated in Orange County this year, there are three that I would like to share with you. Harper Preschool in Newport-Mesa has a collaborative preschool program where every class has special education and general education students working together. There is a program in Anaheim Union High School District that helps middle school students understand personal and school goals in addition to the importance of increasing their API scores and passing the STAR exam. I was able to personally observe Capistrano Unified School District's program, Teaming for the Learning of Children. It combines protected scaffolded reading and math programs, collaboration of professional learning communities, and layers of academic support for all students at five elementary sites. This program serves the diverse needs of each child during the instructional program under the umbrella of the regular education program.

The three programs mentioned are just the tips of the iceberg. Districts across Orange County are doing great things for kids. I encourage you to volunteer to be an evaluator next year so that you too will have the opportunity to observe great programs in other districts.

Declining Enrollment Orange County Experience

Each year, during the first week of October, student enrollment is counted for all districts throughout the state. A preliminary survey of the total county-wide enrollment indicates that 14 of 27 Orange County school districts will experience a decline in enrollment for the current year, which is down from 15 districts in the previous year. Although there is one less district projected to decline in 2005, the total enrollment decline is projected to be greater than the previous year.

There is some protection in current law that provides funding based on the current or prior fiscal year average daily attendance (ADA), whichever is greater. However, for a declining enrollment district, this is a one year protection only. The subsequent year's funding will be based on current year actual ADA, therefore districts experiencing declining enrollment will have to make reductions in the current year to deal with the decline in revenue in subsequent years. Declining enrollment is not unique to Orange County; currently almost half of the school districts statewide are facing enrollment losses in the current year.

Orange County Chosen for National Study

A very special distinction has been bestowed on Orange County, California (OCCA). Orange County has been chosen as a Vanguard Location and will be one of the first six communities in the country to begin participating in the National Children's Study, the largest long-term study of the environment's effects on human health and development ever conducted in the United States. The study is funded by the U.S. Department of Health and Human Services.

By evaluating environmental factors, study researchers hope to determine the root causes of many major childhood and adult diseases. In your community, and in more than 100 diverse communities across the country, local study teams will observe a total of 100,000 children from before birth to age 21 to determine how these factors – such as air, water, and dust, as well as what children eat, how they are cared for, and the safety of their neighborhoods – affect their health and well-being.

The OCCA Vanguard Center is a collaborative effort headed by James Swanson, Ph.D., of the University of California, Irvine. Local teams from the Center, which include collaborators from several UCI groups, Children's Hospital of Orange County, the Orange County Health Care Agency, the Children and Families Commission, and other community organizations, will begin inviting families to participate starting in mid-2007 as part of this decades-long research effort.
