In March 2008, the Orange County Department of Education in association with Arts Orange County brought the best selling author Daniel Pink to speak to an audience of over 800 educators, parents, and community and business leaders. Mr. Pink's book, *A Whole New Mind: Why Right-Brainers Will Inherit the Future*, stimulated a community conversation about the importance of teaching creativity in schools through rich arts education programs for children. The event sparked the imaginations of many attendees about what can be done to address this need. Both the Orange County Department of Education and Arts Orange County have continued this conversation with cadres of key stakeholders.



### Talk About Town: Follow Up on the Community Conversation With Daniel Pink

The Arts Advantage Education Initiative offers services to districts to establish, expand, and extend arts programs in schools. Working with The California Arts Project, districts develop five-year strategic plans with their local community. Thus far, 13 districts have envisioned what these programs will look like and have begun

taking steps to realize them. Two additional districts and a charter school are scheduled to create plans this fall. Early adopters recently completed writing a year-long standards-based curriculum for visual arts, K-6, that will be piloted in eight Orange County schools this fall. Curricula for theatre and dance will be written this school year for implementation in fall 2009.

All schools will have access to a new web-based Resource Directory from Arts Orange County. Listings of professional artists, arts organizations, and artist residencies will allow classroom teachers to select from a variety of resources that will stimulate thinking and support exciting learning opportunities for kids at all levels.

Additional grant funding makes a difference in assuring that the arts get back into schools. Businesses such the Boeing Company and Bank of America realize the critical need for a creative workforce and their foundations are leading the corporate community in aligning the efforts of school districts with professional development opportunities and access to community arts providers.



California State University, Fullerton, is adding a new focus to teacher preparation - that of preparing elementary teachers to integrate the arts across the curriculum. The *Teachers & Students as Artists* series joins the student teacher, master teacher, and teacher education faculty in professional development that has the potential to change the face of education. The new Center for Creativity and Critical Thinking in Education will house the project which will work in association with the Arts Advantage program to pair student teachers with districts. It is anticipated that these skilled teacher graduates will be a boon to Arts Advantage districts in moving their plans forward.

A community "think tank" is being established in south county with the assistance of the California Alliance for Arts Education. The committee led by Patricia Kelley, Mayor of Mission Viejo and Suzie Swartz, School Board President, Saddleback Valley Unified School District, will explore ways to foster increased arts education in local schools for all students.

This summer, the Orange County Performing Arts Center and Orange County Museum of Art partnered to bring Daniel Pink's concept of "six senses" alive through the Arts Teach Leadership Institute. Fifty educators and artists worked with Dr. Victoria Stevens, renowned arts researcher and psychologist, to learn how arts education enhances learning for children. Artist educators on The Center's Arts Teach roster assisted teachers to translate the teachings into classroom lessons.



Additionally, the Curriculum, Standards and Accountability unit of OCDE will be presenting a series of workshops on curriculum integration throughout this next year.

Daniel Pink advises that "the arts should be first among equals" in an education program that prepares students with 21<sup>st</sup> century skills. Orange County is collectively finding innovative and creative solutions to do just that.
